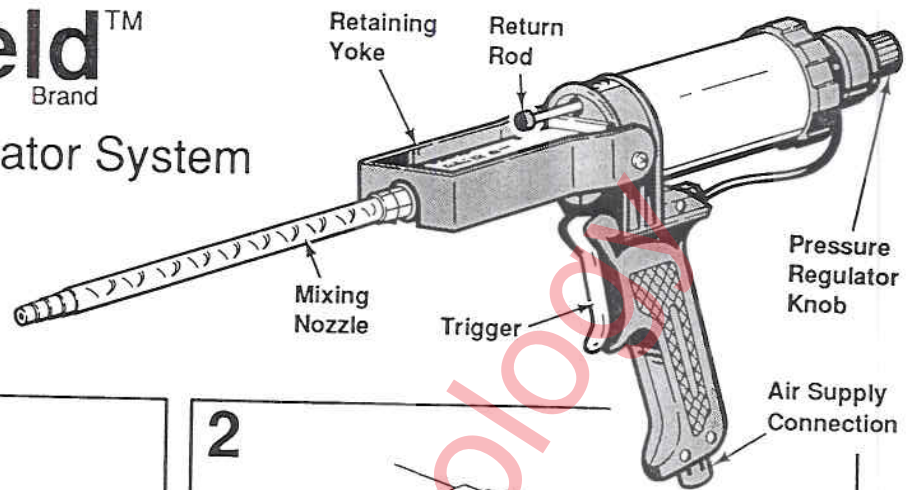


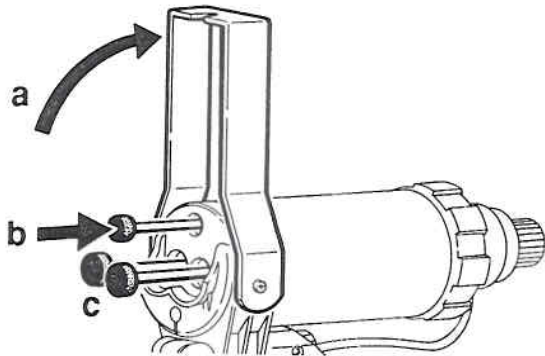

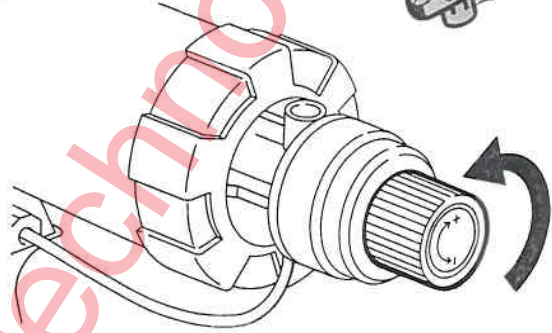
Directions for Use

1



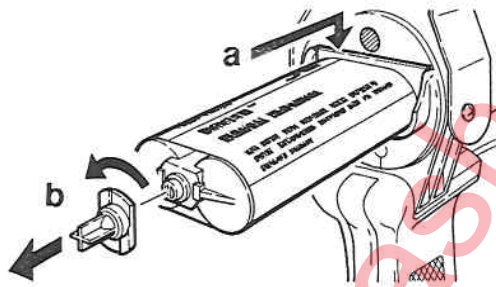
- a Swing retaining yoke up.
- b Push return rod fully into applicator.
- c Plunger disks retract with return rod.

2



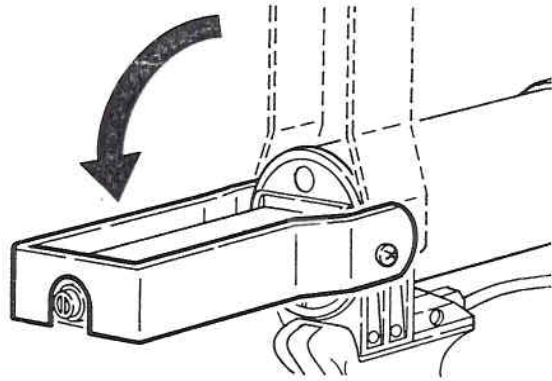
Turn pressure regulator knob fully counterclockwise to minimize pressure.

3



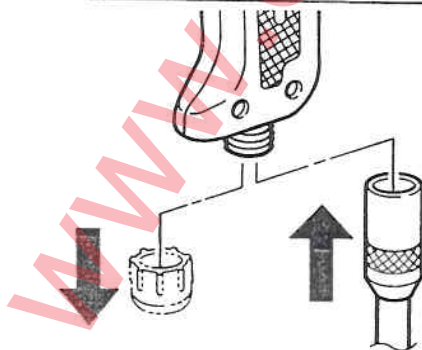
- a Slide Duo-Pak into bracket so top of flange clears return rod.
- b Twist and remove Duo-Pak cap.

Swing retaining yoke down over Duo-Pak.

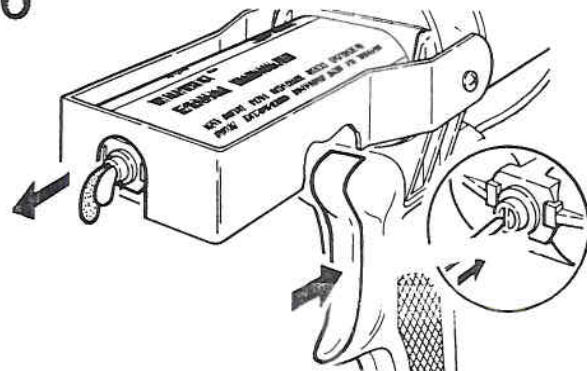


Connect air supply to air supply connection.

WARNING

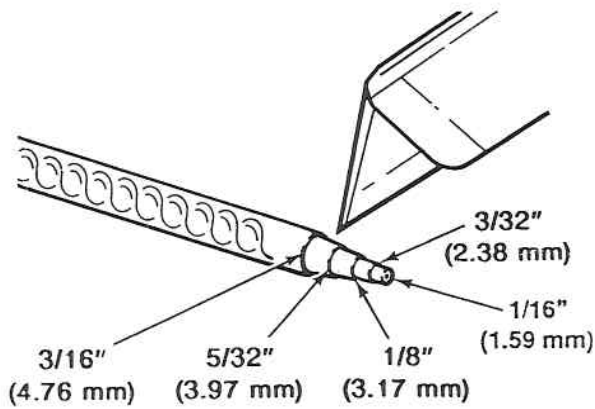
DO NOT ACTIVATE TRIGGER UNTIL YOKE IS HOLDING DUO-PAK CARTRIDGE IN POSITION. DAMAGE TO APPLICATOR AND INJURY MAY RESULT.
KEEP DUO-PAK ORIFICE POINTED AWAY FROM BODY.

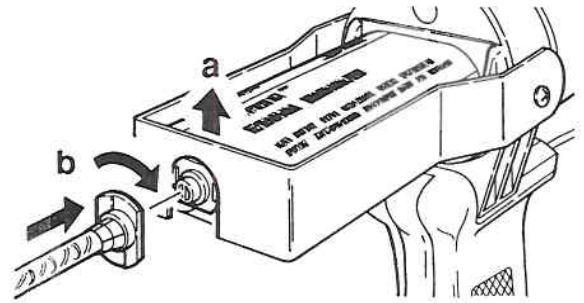
Squeeze trigger to expel a small amount of adhesive. Ensure that both components flow freely. Clear orifice of hardened material if necessary.

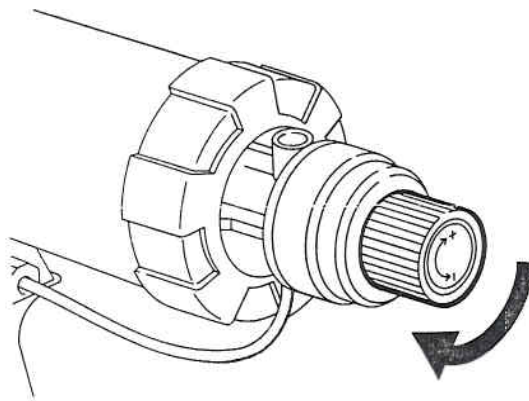
If desired, cut nozzle tip for increased bead size/flow rate.

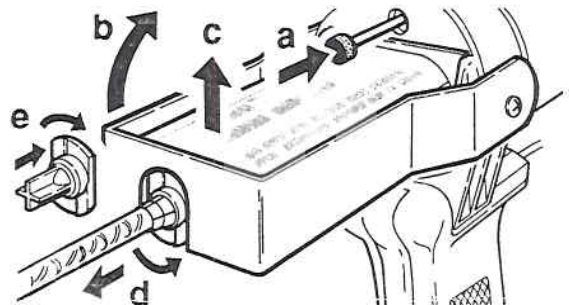
- a Lift yoke slightly if necessary to facilitate mixing nozzle attachment.
- b Twist mixing nozzle into locked position on Duo-Pak tip.

Turn pressure knob clockwise to desired delivery rate.

10 To remove Duo-Pak after use:



- a Push return rod fully into applicator.
- b Swing retaining yoke up.
- c Slide Duo-Pak up and out of bracket.
- To store partially used Duo-pak:
- d Twist and remove nozzle.
Wipe excess material from orifice.
Avoid cross-contact of components.
- e Twist cap into locked position on Duo-Pak.

WARNING
DO NOT ACTUATE TRIGGER WHEN APPLICATOR IS UNLOADED.

11 To reload applicator, disconnect air supply and repeat steps 3-8.

Care of Applicator

Periodically clean any adhesive from plunger disks (refer to figure 1c) with common solvents and detergents. Product data sheets may contain specific procedures. **WARNING: Use proper precautionary measures when using solvents.**
